

Schedule Effective January 1st, 2013 to December 31st 2015

This is Canadian Natural Resources Limited's compensation schedule for adverse effect and loss of use rates on reviews of annual compensation and new surface lease acquisitions within the M.D. of Taber and with Action Surface Rights Association members who own land within the MD of Taber.

Disclaimers:

This Schedule is on a "Without Prejudice Basis" in respect of any current or future negotiations of judicial or quasi-judicial proceedings to which Canadian Natural Resources Limited is a party related to compensation for surface rights takings or reviews in the Taber area.

The parties agree that any rental reviews negotiated between Canadian Natural Resources Limited and the landowners subscribing to this schedule during the period of this schedule will be settled at the rates contained herein.

Canadian Natural Resources Limited retains the final decision in respect of whether or not to apply the rates contained in this schedule to any anniversary dates occurring prior to the effective date of this schedule.

Dry Pasture

Freehold or Private Land:

Loss of Use

\$250.00/acre

Additional well heads after original well will compensated at \$500.00/year.

Dry Land Cultivated

Adverse Effect

\$2000.00 Boundary location

\$2200.00 Inside location with access road under 200m in length. \$2300.00 Inside location with access road over 200m in length.

Loss of Use

\$450.00/acre

Additional well heads after original well will be compensated at \$500.00/year.

Dry Corner Pivot Irrigation

Adverse Effect

\$2400.00

Loss of Use

\$450.00/acre

Additional well heads after original well will be compensated at \$500.00/year.

Partially Irrigated Corner Pivot Irrigation

Adverse Effect

\$2600.00

Loss of use will be calculated based on which portion of the lease is dry land and which area is irrigated.

Additional well heads after original well will be compensated at \$500.00/year if in dry areas and wellheads that are in the irrigated areas will be compensated at \$800.00/year.

Irrigated(pivot, wheel moves, flood irrigation)

Adverse Effect \$3000.00 Wellsite area only within irrigated area, access road dry.

\$3200.00 Wellsite and a short access road that is not built up or

graveled in irrigated area.

\$3400.00 Wellsite and a built up or graveled road in the irrigated area.

Loss of Use

\$700.00/acre (forage crops/cereals/oilseeds/sugar beets and land rented out

for potatoes)

\$1000.00/acre (landowners that actually grow high values crops such as

seed canola, seed alfalfa and potatoes)

Additional well heads after original well will be compensated at \$800.00 year.

Loss of Use values contained in this schedule may vary depending on future agriculture commodity prices. In the event a well of facility is on a home quarter additional adverse effect may be considered.
